Bids were recently accepted for the replacement of the gym roof at West Lafayette Jr./Sr. High School. The advertisement for bids was published in the local newspaper on April 13, 2023 and April 20, 2023 indicating that bids would be opened publicly on May 4, 2023. Fanning Howey assisted with the advertisement and bid process.

Bids were submitted by Hinshaw Roofing & Sheet Metal of Frankfort, Indiana; AAA Roofing of Indianapolis, Indiana; and Foster Contracting of Indianapolis, Indiana. The lowest overall bid was submitted by Foster Contracting with the base bid amount of \$271,700.00 which is line with expectations for the cost of the project. A copy of the final bid tabulation is included in your board packets. We recommend completing the base bid of the project with Foster Contracting, Inc. of Indianapolis, Indiana and not completing the alternates.


