GREINER	<p>Possip</p> <p>We started Pulse Checks in February and continue these each month.</p> <ul style="list-style-type: none"> ● This system allows for quick emailing of what it calls WOW praise to specific individuals. ● Our administrative team will use this WOW praise function to share recognition with staff. ● The system also highlights possible follow-up topics with individual students and/or families. ● Principals are able to act on this information to connect with and support students and/or families. ● The system will provide information in a cumulative format as well as after each Pulse Check. ● In February 96% of the 558 participants were happy or mostly happy with our schools as a whole. ● We fare slightly higher in this area than other schools using Pulse Checks. ● We asked a question about family satisfaction with the level of communication from the schools, and


