A. Budget Hearing

Mr. Sloat began the 2019 Budget Hearing and presented the following information:

- Budgets were advertised in the Journal Courier, Lafayette Leader on August 9, 2018. Additionally, the budget was made available on the corporation website.
- Funds: Education Fund \$14,425,000, Referendum Fund \$7,380,000, Debt Fund \$6,015,000, Operations Fund \$9,520,000, Rainy Day Fund \$1,333,000
- Total 2019 Budget is \$38,670,169
- Expected 2019 Tax Rate is \$1.2762
- The Adoption date is October 1, 2018

Discussion ensued.

B. Academic Achievement – Start of School Update

Dr. Killion reported the corporation student population is continuing to increase; up by 39 students this school year. Construction is on schedule. Ribbon Cutting Ceremony will be held October 10, 2018 at West Lafayette Intermediate School and the school will begin operation October 16, 2018. Cumberland has some minor issues

with the A/C but those issues should be resolved soon. The Jr. Sr. High School Aquatic Center is underway. And ISTEP is delayed because of the vendor, so the school grades will be delayed.

C. Food Service Vendor
