The notes below were written by the chair of the WLCSC Board of Trustees, Rachel Witt, and sent to the members of the WLCSC board of trustees, the Superintendent, and CFO of schools, date as noted. They were written as documents to aid collaboration and contain both informative and deliberative items. They are informal communication, written with the sole purpose of information to board members to facilitate individual members' ability to execute the task each were elected to do. They were not written for any form of publication.

Writing of these weekly notes and distribution to the board is voluntary and can be stopped at any time. A school board may decline to distribute information that is deliberative. Deliberative is defined, in part, as expressions of opinion or thoughts that are of a speculative nature, and that are communicated for the purpose of decision making. Nearly all language in these notes exactly fit the description of deliberative.

The Board Chair, in consultation with corporation and board leadership, is releasing these documents, only minimally redacted, as part of our ongoing work for transparency.

Names/pronouns are redacted to ensure a first-person voice. Other redacted language could include: Legally protected information, i.e. personnel or student names or reference, deliberative information where release of the information could potentially cause harm to a person or group of persons, or inhibit the ability of the board to conduct the business of the board.

General Business

- I met with central office staff on Tuesday to review the draft agenda and give feedback.
- With regard to Nature Center at WLES, (in case you have the same question) I have asked a question pending regarding the plans for long term upkeep. That will be addressed as part of the presentation.
- At the SBOA exit conference, one item of question was the final cost of the audit. As you are aware, we are required by law to be audited, and billed by the state for the price of that audit on a per day rate for as long as the state needs to complete the audit. We have now been billed for that time and I wanted to share with you the hours and cost. To be very clear, neither audit exposed any fraudulent activity or misappropriation. In fact, the auditors started our exit conference by describing the audit as "very good" and when I inquired specifically about any fraudulent activity they said there was none. and when I inquired about the competency and honesty of our CO personnel they were very complimentary and said they had no concern at all. (As a reminder, the auditors had my personal phone number, given at the opening conference, for the purpose of communicating directly with any concerns or fraudulent activity; I was not contacted.)

For the 2017-2019 audit, we paid a total of \$25,374 for 53.58 engagement days. For the 2019-2021 audit, we paid a total of \$48,990 for 128.88 engagement days.

- Engagement agreement finalized with CCHA. It's in our board packet.
- Reviewed Credit Card statements, standard monthly process.
- Update, < Redacted Text> has been able to figure out a way to continue the child of staff transportation between buildings.
- As of right now, we are full staff on certified positions. This was very challenging work for our building admins and REMARKABLE in a state with 3000 teacher openings.
