I. ADMINISTRATIVE RECOMMENDATIONS

Mrs. Cronk prepared a request for Summer School/Jumpstart compensation for staff. The list is included in the personnel packet for your reference.

Mrs. Cronk requests compensation by paid to the Transportation Director for additional days worked during the 2022-2023 school year. This will be processed with the June 20, 2023 payroll.

Mr. Daily has requested transferring 3 food service employees to summer custodial/maintenance help. These are temporary positions from May 30 -August 4, 2023. The employees will resume their food service positions for the 2023-2024 school year in August.

Mrs. Delaney requests compensation for a registered school nurse to attend field trips off school grounds to accommodate a student with medical needs as listed in the IEP.

Mrs. Delaney has requested compensation for staff (certified and paraprofessionals) to assist with Kindergarten screenings on July 25 - July 26, 2023. Screenings will enable Administration to balance classes based upon the student's social, emotional and academic needs.
